**WITNESSETH THAT: WHEREAS,** the parties have entered into ICPT National Basic Ordering Agreement Number HUP BOA 901 dated September 6, 2001, under which the SUBCONTRACTOR has undertaken to provide Beryllium Lymphocyte Proliferation testing services to the DOE and its Contractors and designated affiliates.

**WHEREAS,** the parties now desire to amend said Basic Ordering Agreement (BOA) to make changes.

**NOW THEREFORE,** the parties now desire to amend said BOA as follows:

Delete WSRC and Replace With SRNS, LLC (hereinafter "Buyer") given change in M&O.

**Delete and Replace With:**

The term of ICPT National BOA Number HUP BOA 901 shall be September 6, 2001 through June 30, 2014.

**Reference ARTICLE II – TYPE OF BASIC ORDERING AGREEMENT**

**Delete 1A. (first sentence) and Replace With 1A. (first sentence):**

**1. TYPE AGREEMENT**

- A. This is a Fixed-Unit Price, Indefinite Quantity, Indefinite Delivery, Basic Ordering Agreement as specified in the Price Schedule dated May 3, 2011, Attachment II, and effective for the period stated in Article III.

**Reference ARTICLE III – PERIOD OF PERFORMANCE**

**Delete and Replace With:**

The Agreement period of performance shall be from September 6, 2001, and end on June 30, 2014. Price Schedule dated May 3, 2011 is effective for remaining performance of May 3, 2011 through June 30, 2011, and for the Change Notice No. 6 extension period of July 1, 2011 through June 30, 2014.

**Reference ARTICLE VII – SUBCONTRACTOR'S AUTHORIZED REPRESENTATIVE (SAR)**

**Delete paragraph A. and Replace With paragraph A:**

The Seller shall provide the key personnel identified below in accordance with this article. These personnel are considered to be essential to the work being performed under the Agreement. Prior to diverting any of the specified individuals to other programs, the Seller shall notify the Procurement Representative reasonably in advance and shall submit justification (including proposed substitutions) in sufficient detail to permit evaluation of the impact on the program. No diversion shall be made by the Subcontractor, provided that the DOE Contractor may ratify in writing such diversion and such ratification shall constitute the consent of the DOE Contractor required by this article. The Agreement may be amended from time to time, or an administrative letter may be issued, to either add or delete personnel, as appropriate.



**Reference ARTICLE XV – REPORTING REQUIREMENTS**

**Delete specific Note #3 and Replace With updated Note #3:**

3. Implementing subcontracts may incorporate the requirement for Small, Small Disadvantaged and Women Owned Small Disadvantaged Business Subcontracting Plans, as specified by FAR 52.219-9, and the associated reporting of Individual Subcontracting Reports (ISRs) in the Electronic Subcontracting Reporting System (eSRS).

All other conditions of the ICPT National Basic Ordering Agreement remain the same.
